### ***Why attend?***

The **QCC Retirement Introduction and Overview** webinar covers:

- Maintaining STRS/PERS reporting period control
- Loading STRS/PERS transactions from payroll history
- Reviewing control over duplicate history file loads (QSSUG project)
- Requesting pre-lists, final report and data file
- Maintaining employee retirement data and information
- Managing the Retirement Master and STRS/PERS data
- Entering comments (if available)
- Entering Substitute and Accumulator transactions (if available)
- Requesting retirement reports and miscellaneous jobs
- Managing my|CalPERS data and generating my|CalPERS XML payroll files
- Performing additional edits/cross-checks for my|CalPERS
- Generating pre-payroll STRS/PERS reports and data files

**Participants must self-register.** To self-register:
