- Account Lookup and Account Maintenance
- General Ledger Transaction Maintenance (Fl0002), including Journal Entries, Cash Deposits and Cash Transfers
- Budget Maintenance, including Budget Transfers, transfers from Budget Development and transfers from Position Control
- Standard Accounts Receivable (GLAR "no invoicing" version)
- If time permits: Allocation of Indirect Costs, Account Summarization, and other Core Financial topics
